

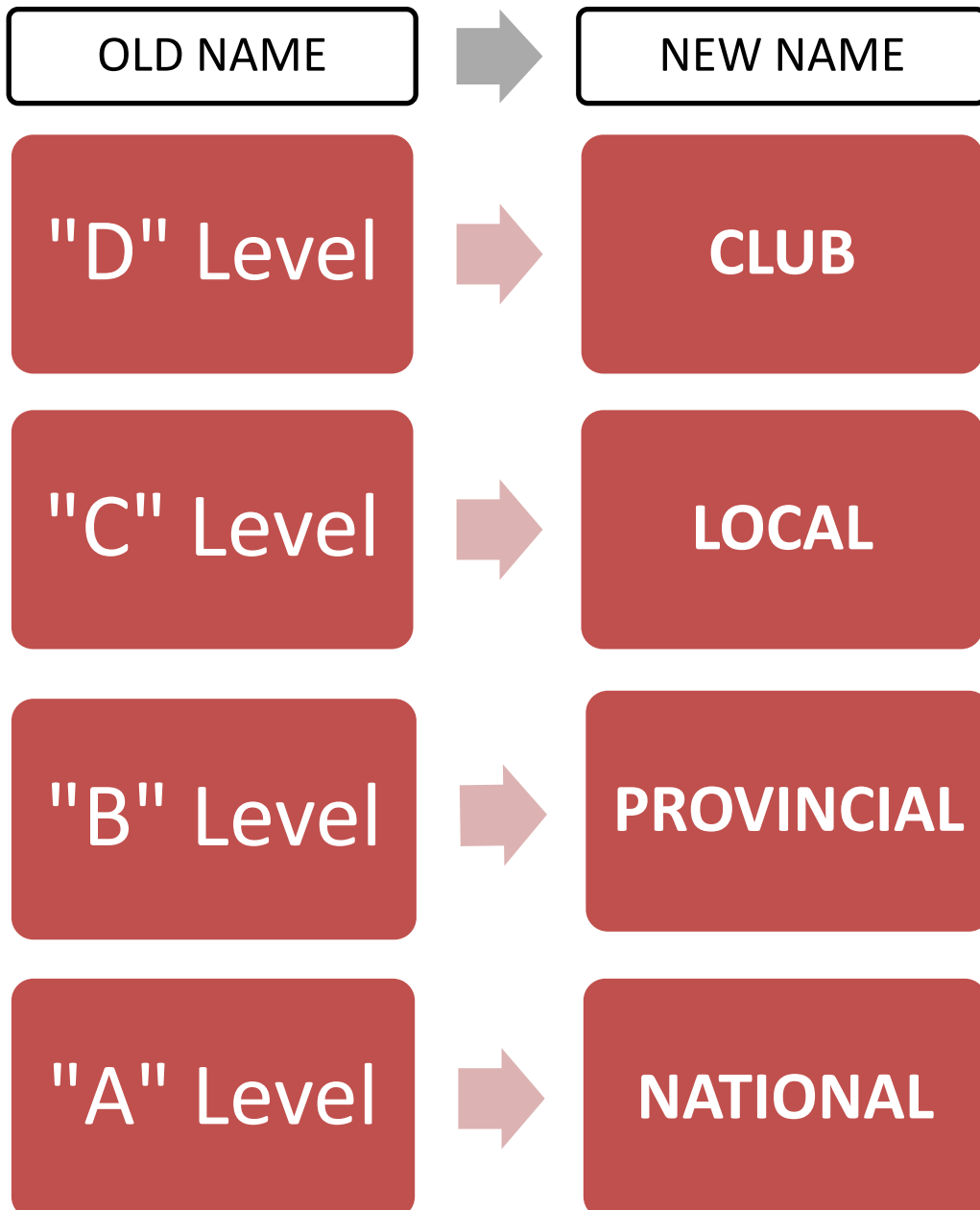


## Squash Canada's Officiating Program

#### WHAT'S NEW?

**Naming:** The levels a Canadian official will go through have been renamed. Individuals currently in the system will be directly mapped from the old system to the new system as follows:





**Signatures:** Within 3 years of implementation of the new system, credit will be given for signatures obtained under the old system as follows:
